



## Lululeopardz Kitten Adoption Contract (Page 1 of 2)

The intent of this contract is to protect \_\_\_\_\_, hereafter referred to as the Buyer, and Lululeopardz, hereafter referred to as the Seller. This contract is legal and binding between the Buyer and Seller.

**Purchase:** The balance is due in full via cash or cashiers check before kitten departs. No personal checks are accepted. No cash refunds. Deposits are non-refundable.

**Buyer:** Under no circumstance will this cat or kitten be sold, leased, or given to a petshop, pound, research laboratory, or any similar facility.

**Cat Welfare:** This cat or kitten will be kept indoors and not be allowed to run free except on a leash or in an enclosed area. If this cat or kitten is neglected or mistreated, Buyer will surrender said cat or kitten.

**Discrepancies:** Any disagreements resulting from the purchase of this cat or kitten will not be published by the Buyer, Seller, or their associates on any media - social media, print, and otherwise. Damages for violation of this clause will be \$5,000.00.

**Health Guarantee:** This cat or kitten is guaranteed for a period of 72 hours from the time the said cat or kitten leaves the possession of Lululeopardz. To validate this guarantee, you must take the cat or kitten to the vet of your choice (at Buyer's expense) within this timeframe. If the cat or kitten is found to have any life threatening problem, it may be returned and a replacement kitten offered as they come available. **No cash refunds.** All shipping expenses from the date of sale are the responsibility of the Buyer. If the cat or kitten is returned to the Breeder, the cat or kitten must be tested for FIP, FIV, and FELV at Buyers expense. Once the cat or kitten leaves the possession of Lululeopardz, Lululeopardz (Rebecca Goodwin) is not responsible for any veterinary bills or charges incurred on said cat or kitten.

Should the cat or kitten die within one year of age as a result of a congenital defect unknown at the time of sale, said cat or kitten will be replaced if an appropriate necropsy is performed by a licensed veterinarian and a certificate is provided showing proof of cause of death. A replacement kitten of comparable quality and value will be provided at the discretion of the Seller. Seller may also elect to give a monetary refund of the purchase price, or a percentage of the purchase price.

**Enforcement:** This contract is legally binding to all parties involved. In the event of default, the Buyer will be legally liable for any and all attorney fees, collection fees, and all related costs necessary to resolve the matter. It is also agreed that any legal matters pertaining to this contract will be held in the State of Missouri, Franklin County.
